Day 01: Kolkata - Arrive Paro (B, L, D)

Arrive Paro our representative will be at the airport to assist you, meet and greet at the airport, Transfer to Hotel with and breakfast. Morning drive to Paro valley and visit **Paro Dzong**, the National Museum housed in a round fortress called as the Ta Dzong considered to be one of the best natural history museums in Asia where it has a fine collection of natural and historic artifacts. Kyichhu Lhakhang the monastery dates to 7th century and is one of the oldest and most sacred. Afternoon visit the ruins of Drukgyel Dzong, a 17th century fortress that used to keep invaders from Tibet and in 1951 the fort was destroyed by fire. Your last stop for the day will be at the base of the world famous “**Tigers Nest** “or popularly known as “**Taksang**” one of the popular spiritual heritage sites. It was here that the great tantric master Guru Padma Sambhava flew in from Tibet on a tiger to bring Buddhist teachings to Bhutan. Evening at leisure. Lunch and dinner at restaurant/ hotel. Overnight stay at Paro.



Day 02: Paro - Thimphu (B, L, D)



After breakfast transfer to the capital city Thimphu. Sightseeing includes the **Folk Heritage Museum, National Library, Handicrafts Center** to view the traditional arts, the indigenous Medicine Hospital, the Painting School and from the road point take a glimpse of **Trashichho Dzong**. Further drive uphill and visit **Takin Zoo** where you will find national animal of Bhutan. Afternoon visit **National Memorial Chorten** a stupa dedicated to the third king of Bhutan and Buddha statue. Evening take a walk to the main city from Clock tower square. Lunch and dinner at restaurant/ hotel. Overnight stay at Thimphu.

Day 03: Thimphu (Meeting full day) (B, L, D)

Breakfast at the hotel. Full day meeting with Bhutan Chamber of commerce Lunch and B2B meeting with business delegates
Dinner at restaurant/ hotel. Overnight stay in Thimphu



Day 04: Thimphu to Paro (B, L, D)

Breakfast at the hotel. Requested appointment with King and Indian ambassador. Meeting will be in morning session based on their availability. Lunch and Dinner at restaurant
Proceed to Paro, Overnight stay in Paro

Day 05: Departure (B)
